- S.O...... (E). In exercise of the powers conferred by section 16 read with section 17 and sub-section (3) of section 25 of the Bureau of Indian Standards Act, 2016 (11 of 2016), the Central Government, after consulting the Bureau of Indian Standards, is of the opinion that it is necessary or expedient so to do in the public interest, hereby makes the following Order, namely: -
- **1. Short title, commencement and application.** This order may be called the Writing and Printing Papers, Coated Paper and Board (Quality Control) Order 2025.
- 2. Conformity to standard and compulsory use of Standard Mark Goods or articles specified in column (2) of the said Table shall conform to the corresponding entry specified in column (3) bearing the title of the Indian Standard in column (4) of the said Table and shall bear the Standard Mark under a license from the Bureau as per Scheme-I of Schedule-II of the Bureau of Indian Standards (Conformity Assessment) Regulations 2018:

Provided that the small enterprises and micro enterprises, as defined under the Micro, Small and Medium Enterprises Development Act, 2006 (27 of 2006) shall conform to such Indian Standards from the date specified in the corresponding entry under columns (6) and (7) of the Table respectively

Provided further that nothing in this order shall apply to goods or articles manufactured domestically for export.

Provided also that nothing in this Order shall apply for up to five tons of goods or articles imported for the purpose of research and development by manufacturers of the said goods or articles per year with the condition that such imported goods and articles shall not be sold commercially and can be disposed of as a scrap and also the manufacturer shall maintain a year-wise record of such goods or articles and furnish the same, if so desired by the Government authorities.
